## Explanatory Notes on Gost-Asia Application Form for Product Certification

### General Note

Much of the information provided by you on the application form will be transcribed exactly into the Gost certificate. As such it will be necessary to provide accurate information on the application form submitted. Please clarify all doubts with Gost-Asia at time of application.

### Notes

- (a) (b) (c) Applicant Details. “Applicant” refers to manufacturer and the certificate is issued to the “Applicant”. If CB or similar supporting document is provided, the applicant’s name in the application form should be the same as that in the supporting document. In case the applicant detail differs from the one indicated in the CB documents, a declaration of authority endorsed by the manufacturer is to be submitted to the certification body Gost-Asia.
- (d) Authorized person who has been designated to apply on behalf of the manufacturer
- (e) Product Description/ Brand Name / Model ID  
This name must be consistent in all product references and documents, on the marking plate, in the CB, operation manual etc
- (f) Note: If more than one manufacturing location is necessary for inclusion in Gost certificate, it should be indicated by submitting full details of “Manufacturer names and addresses” of the additional locations ( Attach details in an annexure if there is space restriction on the form)
- (g) Indicate if you know the standards. Else indicate one of the following (1) “manufacturer’s standards”, (2) “national standards” (3) “international standards”.
- (h) Indicate the actual Russian standard reference if you do know it, else state “Relevant Russian Standards”.
- (i) Indicate the certification scheme if you know it, else leave blank.
- (j) Indicate here the number of additional copies of Gost certificate, hygienic conclusions and /or other information as might be required. Additionally, indicate other approvals such as Telecommunication authority approval, Fire approval, Gosgortekhnadzor, GKRH etc which you require to obtain through Gost-Asia. Indicate HS code of product if available.
- (k) Based on company policy, indicate the number of years you as the manufacturer, plan to support the product with parts from service support standpoint.
- (l) Marking is mandatory on product. Though marking is optional on the packing, it is highly recommended for easy identification to avoid potential problems at customs and trade.
- (m) Signature of authorized person . [ref – (d)]
- (n) Official Company Stamp
- (o) Note that any subsequent applications for amendments etc after the original application is submitted should still reflect the date of the original application here. The new amendment date will be noted separately in our records.
